

## **FINANCE COMMITTEE**

### **A. Membership**

1. The Finance Committee shall consist of at least three Deacons (one from each class of Deacons), at least two Elders, at least three At-Large members, Treasurer of the Presbyterian Women and the Church Treasurer. The senior minister is an ex-officio member of all committees but as a non-church member does not vote.
2. The terms of office for Deacons and Elders shall be for up to three years or until their term of office expires. The term of office for the At-Large members is for one year, renewable for up to three years. The terms of office for Treasurer of the Presbyterian Women and the Church Treasurer are until the term of their respective offices expire.

### **B. Meetings**

The Finance Committee will meet once a month, more or less as needed. The senior pastor should be apprised of meetings in order to participate as he/she desires.

### **C. Duties**

1. The Finance Committee will have oversight of the general financial condition of the church, keeping a proper balance of income and disbursements, according to the approved budget of the church.
2. This committee will have responsibility for any financial campaigns as approved by the Diaconate and/or Session, or the congregation.
3. This committee will keep the congregation informed of the financial standing, needs, and opportunities of the church.
4. This committee will prepare a budget each year for presentation to the Diaconate and Session, with the Session making the final decision on the budget. The congregation must approve changes in the call of the ministers.
5. The Church Treasurer will report monthly as to the financial condition of the church to both the Diaconate and the Session. The moderator of this committee and the church Treasurer will work with the various church committees in the preparation of the budget and the overall stewardship emphasis in the church.
