

## **LONG RANGE PLANNING COMMITTEE**

### **A. Membership**

1. This committee shall consist of at least three Elders (at least one from each of the three classes of Elders), at least one Deacon, at least three At-Large Members, one Youth, and the Presbyterian Women Historian. The senior minister is an ex-officio member of all committees but as a non-church member does not vote.
2. The Term of office for the Elders and Deacons will be for three years or until their term of office expires. The Youth member shall serve a one year term. The term of office for the Presbyterian Women Historian is for her term as Historian. The term of office for the At-Large members is for one year, renewable for up to three years.

### **B. Meetings**

The Long Range Committee shall meet as needed depending on the program being undertaken by the committee. The senior pastor should be apprised of meetings in order to participate as he/she desires.

### **C. Duties**

1. The committee, with the assistance of the Ministers, will be responsible for the long range planning and goals of the congregation.
2. This committee shall look at building and space needs, staffing needs, parking needs, financial needs, etc. as determined by the committee in conjunction with the church staff.
